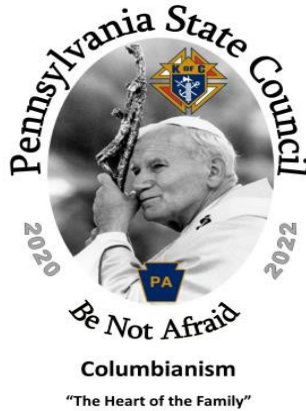

Worthy Financial Secretary and Brother Knight:

In accordance with Chapter II, Section 12 (a) and 13 of the Charter, Constitution and Laws of the Knights of Columbus and Article I, Section 2 of the Pennsylvania State Council By-Laws, your Council is hereby notified that the Pennsylvania State Council will convene for the 123<sup>rd</sup> Annual Meeting at the Penn Stater Hotel, State College, PA from May 20 to May 23, 2021.

The Charter, Constitution and Laws specify, "State Council Delegates shall consist of the Grand Knight and a Past Grand Knight from each subordinate Council in good standing. A Council having no Past Grand Knight may elect any of its 3<sup>rd</sup> Degree members in good standing in lieu thereof as a said representative of said Council in the State Council", as voting alternative delegates. Please comply with these Laws in selecting and reporting Delegates and Alternate Delegates. All delegates must be at least a Third-Degree member.

Enclosed is an "Official Credential" form which must be completed in its entirety, certified by the Grand Knight and Financial Secretary of the Councils and the Seal of the Council must be affixed. Mail the completed "Official Credential" form to the State Secretary.

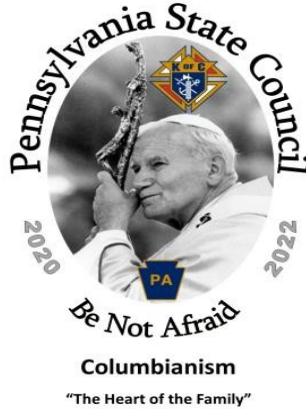
The State Secretary must receive the "Official Credential" form no later than March 31, 2021

Changes and substitutes following this deadline will require an amended "Official Credential" form, so make a copy before completing it. Also, have a delegate bring a copy of your submitted "Official Credential" form with him to the convention.

Your Council is strongly encouraged to exercise its' right to two (2) votes on the business of the State Council. The State Council By-Laws Article 2, strictly prohibits any subordinate Council in default (arrear) of any State or Supreme Council assessments from being represented at the Convention, including committees of the

Convention and Nominees to Supremes" Convention. Please insure you are current in your standing with both or do so before the Convention itself, please feel free to contact me if you are unsure.

**Resolutions** presented for consideration by the State Council need to refer to Article V, Section 5 for the correct procedure. Note that all Resolutions must be typed or printed, certified by the Grand Knight and Recorder, have the Council Seal affixed to each of SIX (6) copies and received by the State Secretary by March 1, 2021. Failure of any of the requirements will result in it being returned.

ALL Delegates and Alternative Delegates must Register (physically sign the provided sheets) with the State Secretary in order to be officially accredited to receive a "Voting" Card. This requires presentation of your current signed membership card and a picture ID such as a PA Driver's License. Not registering at least one Delegate eliminates the Council from any reimbursements or rebates for the convention. Past Grand Knights are the preferred Alternate Delegate but, if there are none available or willing, an elected 3<sup>rd</sup> Degree member will be accepted, He will be elevated to Voting Alternate status if the Delegate fails to appear.

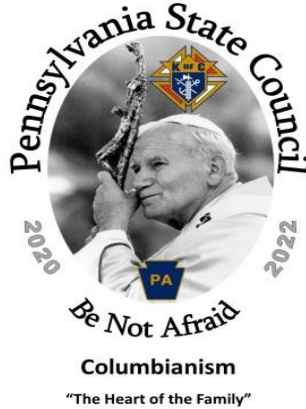
Please note, if a District Deputy or State Chairman wants to be a Delegate for their Council, they must have the credential form filled out with the signature of the Grand Knight and Financial Secretary and include the Council Seal. NO ONE will be allowed to be a Voting Delegate for their Council without submitting the Credential Form, which includes their names and required signatures and the Council Seal, to the State Secretary!

In the past there has been confusion with the multiple registrations for the Convention, there are three (3).

1. You need to register with the Hotel for your room and meal tickets.
2. Register physically with the State Secretary to certify Delegates and Alternate Delegates sign the proper sheets proving attendance for voting and rebate purposes and to receive VOTING cards for each Delegate.

3. Register with the Convention Committee, you will be receiving additional forms from them by way of the preregistration for program advertising booklet, name badges and gifts. (This does not take the place of the Registration with the State Secretary).

Signs will identify each and open times will be listed. Normally, they are open Friday from 1PM to 8PM, prior to the opening Business Session on the first evening. Again, on Saturday 9AM to the conclusion of the Business Session. Sunday morning it will open one half hour prior to the start of the final Business Session. Please make sure that the delegates from your Council know to bring their paid-up current Membership Card,

I would request that you review your Councils financial status with the State and Supreme Councils and comply with all the required items listed in this letter before you arrive. With your held as the Financial Secretary, it will be a smooth event.
